Pandya and Harsh reportedly continued to stay at the Balvant Bhavan with their family and the premise was said to be used for residential purposes.

Some of the family members of the former chief minister then raised an objection before the

SOPS over the alleged violation of conditions of the Gift Deed since conditions of the Gift Deed since the property was being used for residential purpose and no significant social work was being used from there. Later, Balvantrait's daughter-in-law Ralishaben and his relatives Blaskarbnia' lysa and Nilaben Oza Ilide a divil suit in a civil court of Bhavangar. By that time, however, the state government had enacted the Gujarat Land Grabbing (Prohibition) Artin 12000 and the SOPS then decided to file a complaint under the law to get the law to get the

Toddler dies after falling into borewell in Amreli, 4th such incident in a year in state

Was pulled out in an unconscious state after 17hour rescue on

A ONE-AND-half-year-old girl A ONE-AND-half-year-old girl who fellinside aborewellin avillage in Anmeli was pulled out in an unconscious state on Saturday morning after a 17-hour-long rescue operation, involving the National Disaster Response force (NDRT) among others. The toddler, however, could not survive the trauma after falling 50 feet deep, and was declared dead soon after, rescuess aid. This is at least the fourth such incident in Gujarat this year.

tourth such incident in Gujarat this year. Identified as Aarvi, daughter of labourer Karan Amaliyar, the toddler had fallen into the borewell while playing with three other children on a farmin Suragpura village—some 15 km northeast of Amreli town—at argund 12 pm on Friday.

The rescue operation was launched soon after the one-and-a-half-year-old girl fell into the borewell on Friday aftenoon.

"After the rescue operation, which went on for almost 17 hours, we managed to pull the girl out of the borewell at 5:10 girl out of the borewell at 5:10 am on Saturday in an uncon-cious state. A medical team present on the spot immediately attended to her and rushed her to Anmeli evil hospital. However, she was dectared dead on arrival by doctors at the hospital. Fire officer Harkushan Gadhiv told The Indian Express on Saturday. The girl's father is attribal halping from Boriyala village in Dahod district's Garbada talluka in easterm Gujarat. He and his family had been working as agri-

family had been working as agricultural labourers on Bhanu Kakadiya's farm – where the borewell was located – for the last one month, Mukesh Bhuriya, a fellow tribal working with Amaliyar, said. Praveen Poonia, Amaliyar, said. Praveen Poonia, assistant commandant of the 6th battalion of NDRF headquartered in Vadodara and whose Gandhinagar team had joined the rescue after more than a sixhour-long road journey, said that the rescue operation was very challenging.

the rescue operation was very challenging. "Some mud had apparently fallen on the girl after the locals tried to rescue her by carrying out excavation near the borewell. So, the girl was not accessible intially to the rescuers, Secondly, her hands were in a normal po-sition, that is parallel to her torso. Kalu Sabhaya, sarpanch of Suragpura who was at the spot,

Due to that, we were not able to grab hold of her hands with normal hooks and rod mechanism," Poomia said.

The commander said that the rescuers first shifted the soil down the borewell and then managed to reach the girl with rods and ropes.

Gadhvi said that two "J" hooks were fabricated on the spot affer a computer-controlled.

nooks were rabineaced on the spot after a computer-controlled robotic arm failed to pull the girl out. "Given the body position of the girl inside the borewell, the robotic arm was not able to hold robotic arm was not able to hold on the girl tightly enough. Therefore, a fabricator who was called on the spot fabricated two "J" hooks with which we pulled the girl up by around four feet. Then the NDRF managed to catch hold of her with an "L" hook and bring her to the surface," said the fire officer.

We rushed to the spot and found out Anvivas missing. The children told us that she had fallen into the borwell."
